The South Coast Project

The South Coast Project seeks to reduce high risk alcohol use and binge drinking among selective and indicated students in schools in Pescadero and vicinity. The project will be using Project SUCCESS, an evidence-based and replicable Student Assistance Program model for alcohol and drug prevention, which will be supplemented by Peer Leadership Development activities. The anticipated target population annually includes 156 students and an estimated 100 parents/caregivers and other family members (including siblings).

PROGRAM COMPONENT 1. Reduce peer pressure to engage in high risk use of alcohol and binge drinking.

Planning and Collaboration

SMCADS will have lead responsibility for this project. The county wide advisory body Prevention Subcommittee Local Advisory Board will work with the Local Advisory Board, (LAB), encompassing the collaborative agencies, youth and parents. La Honda Pescadero Unified School District will implement Project SUCCESS. South Coast Children's Services is lead agency for peer leadership and Puente de la Costa Sur, will provide parent education, food and housing assistance, mental health services and transportation.

Evaluation

WestED is the evaluator. Data to measure impact will be gathered from the California Healthy Kids Survey every other year and a modified version of CHKS in the off years, pre/post testing for selective and indicated education/group interventions, and focus groups with peer mentoring and education groups in the middle school. Process evaluation of each phase of the project will provide a continuous feedback loop.
