She is responsible for the delivery of over 2,500 TA days per year, overseeing a pool of expert consultants, and ensuring that services and products are research-based, relevant and culturally appropriate.

Over the years, she has established a strong track record in managing the delivery of technical assistance to a broad array of prevention staff in the areas of program design, evidence-based practices and evaluation. Over the past 10 years, Ms. Scott-Nakai has had the opportunity to personally visit, work with, and establish professional connections with the majority of County AOD Offices throughout California. She has over 15 years of assisting federal, state, county, and school and community-based organizations with their prevention efforts.

Specific responsibilities across the projects included general management and oversight of the evaluation components, providing technical assistance and consultation regarding evaluation and program design issues, developing evaluation instruments, monitoring data collection activities, conducting site visits, data management and analysis, and report writing.
